



E23 – WORKING KITAS (Employment)

A working Kitas allows you to work for and earn money from an Indonesian company. The role and specific duties must be in accordance with those designated by the Labor Department. It is valid for, and permits a continuous stay of up to 2 years.

General Requirements	<ul style="list-style-type: none"> → Passport that is valid for at least 18 (eighteen) months. → A recent color photograph. → A personal bank statement showing a minimum equivalent amount of USD \$2,000. The statement must cover the last 3 months and include your name, the date, and the account balance. → Indonesian company formation documents. → ITK/ Permit Number (<i>Applying from within Indonesia</i>)
Additional Requirements for Working KITAS Under Own Sponsorship	<ul style="list-style-type: none"> → ID card of accompanying local workers (Tenaga Kerja Indonesia/TKI). → Salary amount. → Work location and confirmation of office presence if the location is outside the company's registered address. → Employment contract. → WLKP (Mandatory Labor Reporting) account information.

Requirements	<ul style="list-style-type: none"> → Applicant must be physically present in Indonesia to process Kitas renewal. → Renewal needs to be processed within 1 - 3 months before your Kitas expires.
