The Investor KITAS is available to foreigners wanting to invest or establish a company in Indonesia. This visa allows multiple entries and is valid for, and permits a continuous stay of up to 2 years.

General Requirements	<ul style="list-style-type: none"> → PMA (Foreign Investment Company) company document → Passport that is valid for at least 6 (six) months. → A recent color photograph. → A personal bank statement showing a minimum equivalent amount of USD \$2,000. The statement must cover the last 3 months and include your name, the date, and the account balance. → Evidence of share ownership of at least Rp10,000,000,000.00 (ten billion rupiah) or equivalent in the guarantor company listed in the Ministry of Investment / Indonesia Investment Coordinating Board. → Ministry of Law and Human Rights Decree regarding the legalization of the establishment the company. → Company current account for the last 2 (two) months. → ITK/ Permit Number (<i>Applying from within Indonesia</i>)

The statement must cover the last 3 months and include your name, the date, and the account balance.
Requirements	<ul style="list-style-type: none"> → Applicant must be physically present in Indonesia to process Kitas renewal. → Renewal needs to be processed within 1 - 3 months before your Kitas expires.
