



E32 – EX-INDONESIAN (GOLDEN VISA - DIASPORA)

The Ex-Indonesian Golden Visa is for former Indonesian citizens and their foreign children. E32 A/B Visa holders can also apply for family visas for their spouses, or parents.

E32A – Ex-Indonesian Citizen 5 years

E32B – Descendant of An Ex-Indonesian 5/10 years

Length of Stay	5 years or 10 years
Processing Time	→ Regular takes up to 60 business days.

With this visa you MUST	→ Report on the compliance of commitments within 90 days after the date of entry
Visa validity	This visa must be used within 90 days from the date of issue.
General Requirements	→ Passport that is valid for at least 6 (six) months. → A recent color photograph. → A personal bank statement showing a minimum equivalent amount of US \$2000. The statement must cover the last 3 months and include your name, the date, and the account balance. → ITK/ Permit Number (<i>Applying from within Indonesia</i>)
Additional Documents	<p>Ex-Indonesian Citizen (E32A)</p> → Statement of commitment to purchase one of the following: <ul style="list-style-type: none"> ✓ Indonesian Government bonds of at least US \$35,000. ✓ Shares in listed companies in Indonesia of at least US \$35,000. ✓ Mutual funds in publicly listed companies in Indonesia of at least US \$35,000. → Documents that prove the applicant has been an Indonesian citizen such as: <ul style="list-style-type: none"> ✓ Identity card (KTP); ✓ Birth certificate; ✓ Family card (KK); ✓ Passport of the Republic of Indonesia; ✓ Diploma, or ✓ Land certificate. → These obligations must be fulfilled no later than 90 days after the ITAS is granted.
	<p>Second-degree Ex-Indonesian Citizens (E32B)</p> → Statement of commitment to purchase one of the following: <ul style="list-style-type: none"> ✓ Indonesian Government bonds of US \$50,000. ✓ Shares in listed companies in Indonesia of at least US \$50,000. ✓ Mutual funds in publicly listed companies in Indonesia of at least US \$50,000. → Documents that prove the applicant first or second degree of an Indonesian citizen such as: <ul style="list-style-type: none"> ✓ Birth certificate; ✓ Family card (KK) or ✓ Marriage certificate. → These obligations must be fulfilled no later than 90 days after the ITAS is granted.

Renewal:

Information	Description
Length of Stay	5 years or 10 years
Processing Time	40 business days.
Document Requirements	→ Passport that is valid for at least 6 (six) months. → Proof of living expenses of at least USD 2,000 (two thousand US Dollars) or equivalent
Requirements	→ Applicant must be physically present in Indonesia to process KITAS renewal. → Renewal needs to be processed within 1 - 3 months before your KITAS expires.
Price	→ IDR 40.000.000 (Stay 5 years). → IDR 50.000.000 (Stay 10 years).
