Additional Requirements	<ul> <li>Ex-Indonesian 1 year:</li> <li>→ Statement of commitment to purchase one of the following:</li> <li>✓ Indonesian Government bonds of at least US \$15,000.</li> <li>✓ Shares in listed companies in Indonesia of at least US \$15,000.</li> <li>✓ Mutual funds in publicly listed companies in Indonesia of at least US \$15,000.</li> <li>→ These obligations must be fulfilled no later than 90 days after the ITAS is granted.</li> </ul>
