This Digital nomad visa is designed for remote workers who wish to live in Indonesia while working for foreign companies. This visa is valid for up to 1 year and is renewable.

General Requirements	<ul style="list-style-type: none"> → Passport that is valid for at least 6 (six) months. → A recent color photograph. → Personal bank statement with a minimum balance of USD \$2,000 or equivalent for the last 3 months period (including name, dates and corresponding balances). → Proof of annual income of an amount equivalent to 60,000 USD. → Remote worker employment contract with overseas company. → Certificate of incorporation of employing company. → ITK/ Permit Number (<i>Applying from within Indonesia</i>).

Document Requirements	<ul style="list-style-type: none"> → Passport that is valid for at least 18 (eighteen) months. → A personal bank statement showing a minimum equivalent amount of USD \$2,000. The statement must cover the last 3 months and include your name, the date, and the account balance.
Requirements	<ul style="list-style-type: none"> → Applicant must be physically present in Indonesia to process KITAS renewal. → Renewal needs to be processed within 1 - 3 months before your KITAS expires.
