



## E31 – DEPENDENT OF KITAS HOLDER (FAMILY KITAS)

Dependent family members of KITAS and long-stay visa holders (including Golden Visa, Working, Investor and Kitap) are allowed to reside in Indonesia as dependents of their sponsoring family member.

| <b>Additional Requirements</b>    | <p><b>Spouse Kitas:</b></p> <ul style="list-style-type: none"> <li>→ Marriage certificate translated into Indonesian by a sworn translator.</li> <li>→ A valid Limited Stay Permit/Permanent Stay Permit or Limited Stay Visa of the husband or wife.</li> </ul> <p><b>Child Kitas:</b></p> <ul style="list-style-type: none"> <li>→ Marriage certificate translated into Indonesian by a sworn translator.</li> <li>→ Birth certificate translated into Indonesian by a sworn translator.</li> <li>→ Parents' valid Limited Stay Permit/Permanent Stay Permit or Limited Stay Visa.</li> </ul> <p><b>Parent Kitas:</b></p> <ul style="list-style-type: none"> <li>→ Birth certificate translated into Indonesian by a sworn translator.</li> <li>→ The children's valid Limited Stay Permit/Permanent Stay Permit or Limited Stay Visa.</li> </ul> |

| <b>Requirements</b>          | <ul style="list-style-type: none"> <li>→ Applicant must be physically present in Indonesia to process Kitas renewal.</li> <li>→ Renewal needs to be processed within 1 - 3 months before your Kitas expires.</li> </ul>   |
